Calvary Evangelical Lutheran Church, as a standing resolution, to remain in force and effect until such time as amended or revoked, hereby authorizes and establishes a housing allowance for DCE Aaron Finkel for the duration of service in an amount each year up to thirty percent (30%) of said person's annual compensation. Annual Compensation of base salary, parish factor, housing, and utility.
