-Terry motioned that organizations remain the same except that Hope Foundation would be replaced by WeLift Compassion Fund. Jen seconded the motion. The motion was approved by unanimous vote.

Jake motioned that the 2026 Mt. Calvary Church Council Budget be approved. Natasha seconded the motion. The motion was approved by unanimous vote.

Jake motioned that we take the \$25,000 from the endowment fund into our general budget.

Terry seconded the motion. The motion was carried unanimously.

# An Executive Summary of the 2025 Convention of Iowa District West

Pastor Vanderbilt and Ken Tague attended the  $42^{nd}$  Convention of Iowa District West at Camp Okoboji from June 8-10, 2025. Every congregation of the District is allocated a pastoral and lay delegate. The following is a quick summary of the three days of proceedings.

#### **Elections**

The Rev. Dr. Steve Turner did not seek re-election as District President, instead retiring from ministry after 40 years total. Rev. Paul Egger (St. John, Galva) was elected the new District President and was installed at the convention. He began his duties in late July of this year.

The Rev. Jonathan Riggert (Trinity, Cherokee), formerly  $2^{nd}$  Vice President of Iowa District West, was elected as  $1^{st}$  Vice President. Rev. Ben Dose (Trinity, Algona) was elected to serve as  $2^{nd}$  Vice President.

Pastor Vanderbilt let his name stand for election as chair of the Human Care Committee but was not elected. Rev. Chadrich Dietrich (Immanuel, Rockwell City and Trinity, Manson) was elected to that position.

However, it was revealed in October that Rev. Riggert had left the ministry and was no longer able to serve as 1<sup>st</sup> Vice President. Therefore, per District by-laws, Rev. Dose was promoted to 1<sup>st</sup> Vice President and Rev. Chadrich Dietrich was appointed by President Egger to become 2<sup>nd</sup> Vice President. This caused the District's Human Care Committee to become vacant and President Egger has appointed Pastor Vanderbilt to this role.

Also, Rev. Michael Barnes (Peace, Des Moines) has also retired from the ministry, leaving a vacancy in the role of Circuit Visitor for the Des Moines East Circuit (Mt. Calvary's circuit). Rev. Kevin Johnson (Holy Cross, Carlisle) was elected by the circuit to fill this role.

#### Resolutions

Actions taken in District Convention are not binding to local congregations. They are always given as suggestions and directions for congregations to consider. However, they may be binding to the District and so they can serve as a way for the people of Iowa District West to bring their concerns to the District. Here are the first batch of Resolutions that were considered by the Convention:

- "To Promote Wellness Among Church Workers"
- "To Build a Culture of Church Work Formation and Recruitment"
- "To Encourage Every Congregation to Enact Sexual Abuse Prevention Strategies"
- "To Give Thanks for the One True Faith as Confessed in the Nicene Creed on Its 1700th Anniversary"
- "To Support and Encourage Adoption"
- "To Commission a Study to Support Ethnic Ministry Pastors and Commissioned Workers"
- "To Advance the Reach of Word and Sacrament Ministry in Our Local Community"
- "To Allow Greater Access to the Lutheran Confessions"

The Resolutions to support adoption and to commission a study on ethnic church workers will be sent by the District as overtures to the Synodical Convention in 2026. All the resolutions above were passed except for the final one concerning the Lutheran Confessions. It was defeated because there was not enough information on the accessibility of the materials in question.

The second batch of Resolutions that were presented for consideration were the following:

- "To Recognize and Give Thanks for the Leadership of President Steven Turner"
- "To Strengthen through Realignment Congregations of Circuits 1, 6, 8, 16"
- "To Bring Awareness to Congregations by Encouraging Them to Develop a Disaster and Risk Response Plan"
- "To Support the Compassionate Mission of Lutheran Family Service"
- "To Embrace Biblical Stewardship for the Flourishing of Christ's Mission"
- "To Review the Handbook of Iowa District West"

The resolution on re-alignment had a minor impact on Mt. Calvary as the Des Moines East Circuit (Circuit #8) gained Our Savior's in Leon and Immanuel, Osceola to our group. This realignment was necessary due to Synodical requirements for circuits. The LCMS bylaws state that a circuit must have between seven and twenty congregations with a combined total of 1,500 to 10,000 confirmed members. The former Circuit 16 (Clarinda, Shenandoah, Villisca, Bedford, Corning, Leon, and Osceola) was disbanded because they had dropped below 1,500 confirmed members between their 10 congregations. Those 10 congregations were assigned to Circuits 1, 6, and 8 as recommended by the committee.

Pastor Vanderbilt can provide more details on these as requested, but most of these were perfunctory. He can also share a complete record of the proceedings and resolutions to anyone who would like them.



September of this year was the 20th anniversary of the dedication of this building.

# NOTE: Decorating for the Christmas Season will be Saturday December 6th at 9am.

This past year has seen many maintenance updates to our building.

- A pantry has replaced the preschool bathroom, which now helps everyone monitor food supplies that are used for midweek and mid-summer meals.
- The outside door and lock to the kitchen was replaced.
- The Front Doors to our building were replaced.
- A 15-Passenger Van that was purchased last year, has been very helpful when attending events, including travel to the National Youth Conference in New Orleans this past summer.
- The Council approved the replacement of the east parking lot, which is now complete. The property board will seed the areas along the curbs next spring.
- Thank you to the Beautification Committee for their devotion in keeping the landscape looking great all season long.
- The landscape plants in front of the Sanctuary were replaced last spring and have greatly improved the looks of the front of the building.
- Pond
  - We want to thank Steve Roush for his devotion, labor and equipment in converting the pond from an eyesore to one that will be a blessing to our congregation.
    - a. A firepit was installed, along with a trailer full of wood for members to use.
    - b. A walking trail was created around the pond and has been seeded so anyone is welcome to walk the trail to experience the wonders of the outdoors.
    - c. The pond has been stocked with some fish, with more to be added each year, which means fishing will improve in about three years.
- The ceiling in the fellowship hall will be repaired and plans are to install a new access to make it easier to repair the building's sprinkler system.
