CONSENT TO COUNSEL

Our Goal

The goal of counseling at Three Rivers Church is to provide biblical counseling to help you meet the challenges of life in a way that will please and honor Christ (1 Cor. 10:31) and in a way that will bring you the greatest joy and satisfaction (Jo. 15:11).

Biblical Basis

We believe that the Bible provides thorough guidance and instruction for faith and life (2 Tim. 3:16-17; 2 Pet. 1:3). Therefore, our counseling is based upon scriptural principles. *Our counselors are not trained or licensed as psychotherapists or mental health professionals, nor should they be expected to follow the methods of such specialists.*

All counseling will be conducted in accordance with the counselor's understanding of the Scriptures. However, our counselors do not know all there is to know about biblical teaching and its application to life. Therefore, when necessary, they will seek help, input, or advice from pastors, mentors, or colleagues.

Not Professional Advice

If you have significant legal, financial, medical or other technical questions, you should seek advice from an independent professional. Our counselors will cooperate with such advisors and help you to consider their counsel in light of scriptural principles. Our counselors do not give professional advice.

Our Fee

We seek to bless our body of believers and the community by providing biblical counseling services. Our counselors volunteer their time and that time is important. Through them, we can offer these services free of charge. In order to provide good, helpful resources, we ask you to pay for the reading materials you will need if it is part of your counseling plan. Out of respect for our staff, we require a \$25.00 deposit which will be refunded to you should you keep all of the appointments or cancel an appointment 48 hours in advance of the scheduled appointment time. When you come to your first counseling session, the deposit will be required in cash. If you should ever cancel less than 48 hours in advance, you would forfeit your cancellation fee. To continue counseling should this occur, another \$25.00 deposit would be required before counseling is continued.

Counseling Minors

We believe the primary responsibility for shepherding and discipling children and teenagers rests with their parents. Accordingly, when counseling children and teenagers, the counselor may share information from the counseling sessions with either or both of the custodial parents if the counselor believes it is wise to do so.

Informed Consent and Confidentiality

Confidentiality is an important aspect of the counseling process, and we will carefully guard the information you entrust to us. However, there are times in which the counselors may believe that it is wise or mandated (biblically or legally) for them to share certain information with others.

Some examples include, but are not limited to:

1. When a counselor is uncertain how to address a problem and needs to seek advice from a pastor or another counselor.
2. When there is concern that someone may be harmed unless others intervene.
3. When abuse or another crime must be reported to the authorities.
4. When a person refuses to renounce a particular sin and it becomes necessary to seek the assistance of others in the church to encourage repentance and reconciliation or to begin the process of church discipline (Pro. 15:22, 24:11; Matt. 18:15-20).
5. When observers sit in on counseling sessions to assist the counselor or for training purposes (including audio and video recordings – only with permission).
6. When the counselee’s pastor, staff and/or church leadership is needed to provide pastoral assistance.

Please be assured that our counselors strongly prefer not to disclose personal information to others. They will make every effort to help you find ways to resolve a problem as privately as possible.

Resolution of Conflicts (Arbitration)

On rare occasions, a conflict may develop between a counselor and a counselee. In order to make sure that any such conflicts will be resolved in a biblically faithful manner, we require all of our counsees to agree that any dispute that arises with a counselor or with the church as a result of counseling will be settled by mediation and, if necessary, legally binding arbitration in accordance with the Rules of Procedure of the Institute for Christian Conciliation; judgment upon an arbitration award may be entered in any court having jurisdiction. *It is expressly understood that by agreeing in advance to arbitrate that the counselee is giving up his right to a trial in the civil courts.*

Conclusion and Signature

Having clarified the principles and policies of our counseling ministry, we welcome the opportunity to minister to you in the name of Christ and to be used by Him as He helps you to grow in spiritual maturity and prepares you for usefulness in His body.
